Mika Blain said she has not read through it as she was on vacation and she would like a chance to review it and talk with her staff. Commissioner Boyd said we should table this until Counsel can review. Board agreed, item tabled to next week's Business meeting.

Jeremy Morris addresses the Board. Commissioner DeGroot motions. Commissioner Morris seconds. Commissioner Morris asks Commissioner Boyd if he got his concerns resolved. He said he doesn't want to stand in the way of the project, he does not agree with the project but if the citizens are happy, he thinks this is a project we should continue with. Commissioner Morris asks if the value of the properties was broken out or specified somewhere. Mr. Morris said, yes it's in the agreement. Unanimous vote. Approved.

Rochelle Long addresses the Board. Commissioner Boyd motions. Commissioner Morris seconds. Commissioner Boyd asks about 6A if the language "as needed" if appropriate. Ms. Blain said, yes. Commissioner Boyd said he appreciated the committee not having meetings just to have meetings. Unanimous vote. Approved.

11. Commissioner Reports



Commissioner DeGroot - He went to the National Association of Counties conference last week. He learned a ton and made connections that he hopes will bear fruit. He met with a gentlemen from Coconino County and discussed their efforts to extend their tourism season. He carried a Resolution from the Association of Oregon Counties pertaining to the Mortgage Electronic Registration System, MERS that passed. It was a request to congress that would study the fiscal impacts and service impacts because of MERS. He wrote an Op-Ed regarding safety, slowing down and paying attention in construction zones. He encouraged citizens to pay attention and slow down. He is continuing to work on the temperature TMDLs regarding the restrictions on how we can unload our discharge water.

Commissioner Morris - She attended the National Association of Counties conference last week. She carried a resolution related to requesting the federal government fund research around kratom. The resolution passed unanimously. She had a lengthy conversation with someone at the FDA about how they work with the DEA to list something as a controlled substance and kratom is in this process. She went to the Business Oregon meeting on Friday in Scapoose. The Board has supported getting an area in Klamath County designated as a Regionally Significant Industrial Site. It's a program in partnership with the State that helps us get an industrial site shovel-ready. She hopes the Board will continue to designate other sites.

Commissioner Boyd - He has been working with DHS trying to improve our plight with the homeless and less fortunate citizens. He will continue the work today at Klamath Works where Judge Anne Aiken will present a program to help people get direction after being released. He went to Rocky Point this weekend and attended their summer celebration and fundraiser for the Rocky Point Fire Department. He is working on bringing a fun and exciting restaurant opportunity to the Medo Bel Dairy site.
