July 31, 2020

Klamath County reported a new case, bringing the total to 194. Six deaths brought Oregon's toll to 322. Oregon Health Authority reported 373 new confirmed and presumptive cases, bringing the state total to 18,492.

Oregon's 319th death was a 55-year-old man in Multnomah County who tested positive July 28 and died July 29, at Adventist Medical Center. He had underlying conditions.

Oregon's 320th death was a 58-year-old man in Umatilla County who tested positive July 7 and died July 29, at Kadlec Regional Medical Center in Richland, Wash. He had underlying conditions.

Oregon's 321st death was a 70-year-old man in Multnomah County who tested positive July 3 and died July 30, at Legacy Emanuel Hospital. He had underlying conditions.

Oregon's 322nd death was an 81-year-old man in Lincoln County who tested positive June 23 and died July 29. He had underlying conditions.

At 5 p.m. Pacific Time, there were 4,705,018 cases in the United States, with 2,327,072 recoveries and 156,741 deaths. National testing reached 58,579,205, with the global tally at 338,137,117. Worldwide there were 17,744,784 cases, with 10,945,479 recoveries and 682,191 deaths.

July 30, 2020

Oregon's 313th death was an 85-year-old man in Multnomah County who tested positive July 15 and died July 27, at Providence Portland Medical Center. He had underlying conditions.

Oregon's 314th death was a 68-year-old woman in Umatilla County who tested positive July 10 and died July 28, at Kadlec Regional Medical Center in Richland, Wash. She had underlying conditions.

Oregon's 315th death was a 66-year-old man in Multnomah County who tested positive July 18 and died July 26, at Portland Adventist Medical Center. He had underlying conditions.

Oregon's 316th death was an 82-year-old man in Multnomah County who tested positive July 4 and died July 23, at Providence Portland Medical Center. He had underlying conditions.

July 28, 2020

Klamath County announced three new cases bringing the count to 184. Fourteen deaths brought Oregon's toll to 303.

Oregon Health Authority Director Patrick Allen provided a message of condolence: "As we surpass 300 deaths related to COVID-19, including the 14 deaths reported today, I wish to extend sincere condolences on behalf of everyone at OHA to the families who have lost a loved one to this disease. It is a stark reminder of the work all Oregonians need to do to bring this pandemic under control. Together we can slow this disease and prevent this terrible loss of life."

Oregon's 298th death was a 78-year-old woman in Deschutes County who tested positive July 12 and died July 23. She had underlying conditions.

Oregon's 299th death was a 64-year-old woman in Jefferson County who tested positive July 14 and died July 27.

Oregon's 300th death is an 82-year-old female in Jefferson County who tested positive on July 20 and died on July 26. Location of death is being confirmed. She had underlying conditions.

Oregon's 301st death is an 87-year-old man in Marion County who tested positive July 14 and died July 26 at Salem Hospital. He had underlying conditions.

Oregon's 302nd death was a 66-year-old woman in Marion County who tested positive July 14 and died July 24. She had underlying conditions.

Oregon's 303rd death was an 84-year-old female in Umatilla County who tested positive July 22 and died July 25. She had underlying conditions.

Nine deaths brought Oregon's death toll to 282. The deaths are the highest number of deaths reported in a single day in Oregon since the start of the pandemic. Oregon Health Authority reported 396 new confirmed and presumptive cases, bringing the state total to 16,104.

Oregon's 274th death was a 61-year-old woman in Multnomah County who died July 18 at her residence. The death certificate listed COVID-19 disease, or SARS-CoV-2, as a cause of death, or as a significant condition that contributed to her death. No confirmatory testing for COVID-19 was performed, but this aligns with the CSTE probable case definition for a presumptive case, which OHA follows.

Oregon's 275th death was a 68-year-old woman in Clackamas County who tested positive June 5 and died July 16, at Providence Portland Medical Center. She had underlying conditions.

Oregon's 276th death was a 92-year-old man in Deschutes County who tested positive July 12 and died July 18. He had underlying conditions.

As of Friday, July 24, indoor venues such as restaurants, bars, gyms, movie theaters and houses of worship must limit occupancy to 100 people, down from 250, Gov. Kate Brown announced during a press briefing. Restaurants and bars will close by 10 p.m. instead of midnight in counties that are in Phase 2 of reopening, which covers much of the state. Lincoln, Multnomah, Clackamas and Washington counties were still in Phase 1.

Oregon's 253rd death was an 82-year-old woman in Clackamas County who tested positive July 6 and died July 16, at her residence. She had underlying medical conditions.

Oregon's 254th death was a 35-year-old woman in Multnomah County who tested positive July 6 and died July 11, at her residence. She had underlying medical conditions.

At 1:30 p.m. Pacific Time In the United States there were 3,745,950 cases, with 1,697,910 recoveries and 141,678 deaths. National testing reached 46,309,397, while globally the tally was 287,325,394. Worldwide there were 14,105,650 cases, with 8,187,880 recoveries and 595,545 deaths.

July 16, 2020

Two deaths brought the state's death toll to 249. Oregon Health Authority reported 437 new confirmed and presumptive cases, bringing the state total to 13,509.

The case count is the highest since the onset of the pandemic. The rise in cases was attributed to the spread of COVID-19 from social gatherings and sporadic spread. Worksite outbreaks and long term care facility outbreaks also are contributing cases to the daily count.

Since Oregon began reopening, there have been outbreaks when people get together to celebrate with family and friends. Some examples include:

- Graduations
- Birthdays
- Weddings
- Holidays

COVID-19 is spreading more among social activities involving groups of younger people. OHA has recorded outbreaks linked to:

- An exercise classes
- A fraternity party
- A bachelor party

While it is difficult not to celebrate these events as in the past, COVID-19 is spreading in communities and people must think hard about altering daily routines that may put people at risk.

OHA recommended that everyone:

- Limit the size of gatherings
- Keep distance from others
- Cover faces
- Find alternative ways for those who are vulnerable to participate.

Oregon's 248th death was a 97-year-old man in Malheur County who tested positive June 29 and died July 15, at his residence. He had underlying conditions.

Oregon's 249th death was a 58-year-old woman in Malheur County who tested positive July 6 and died July 13.

Oregon's 247th death was a 61-year-old woman in Douglas County who tested positive June 28 and died July 12, at Covenant Hospital in Lubbock, Texas. She had underlying conditions.

OREGON HEALTH AUTHORITY NOTE: The death of a 71-year-old woman from Multnomah County who died May 5 was accidentally reported twice — once in the May 7 press release as Oregon's 120th death, and again in the May 8 press release as Oregon's 124th death. The total number of deaths today was amended to reflect this change.

Oregon's 241st death was a 91-year-old man in Lincoln County who tested positive June 29 and died July 10, at his residence. He had underlying medical conditions.

Oregon's 242nd death was a 77-year-old woman in Marion County who tested positive June 24 and died July 13, at her residence. She had underlying medical conditions.

Gov. Kate Brown announced Oregon will ban indoor social gatherings of more than 10 people and will require people to wear face coverings outdoors when they cannot maintain a 6-foot distance from people outside their households. These measures take effect Wednesday.

Two worksite outbreaks reported of 20 cases or more. An outbreak of 20 cases was reported at Shearer's Foods in Umatilla County. The case count includes all persons linked to the outbreak, which may include household members and other close contacts to an employee. The outbreak investigation started June 26, but the initial case count was below the threshold for public disclosure.

An outbreak of 102 cases was reported at Snake River Correctional Institution in Malheur County. The case count includes all Oregon residents linked to the outbreak, which may include household members and other close contacts to an employee. The case count does not include any Idaho residents who may

be associated with the outbreak, as laboratories report positive tests results to the state in which an individual resides. OHA is working closely with Idaho to coordinate contact tracing across state lines.

The outbreak investigation started June 24, but at that time the case count was below the threshold for public disclosure. The outbreak was reported in the COVID-19 Weekly Report on July 8 with six cases.

State and county public health officials are working with these organizations to address these outbreaks and protect the health of workers.

Governor Kate Brown identified eight counties that will be placed on a "Watch List" based on these data: Jefferson, Lake, Lincoln, Malheur, Morrow, Umatilla, Union, Wasco. State and local health officials will closely monitor the situation in these counties in coming days and prioritize additional resources to suppress the virus in these hotspot communities.

Earlier in the week, Governor Kate Brown ordered face coverings to be worn in all indoor public places throughout the state. Masks and face coverings, along with maintaining six-feet of distance between people was reported to contain the spread of COVID-19.

At 10 a.m. Central European Summer Time the World Health Organization reported 10,533,779 cases worldwide with 512,842 deaths. In the United States there were 2,616,949 cases with 127,133 deaths.

More information was available about Oregon's 192nd death, which was initially reported June 22. She was a 90-year-old woman in Marion County who tested positive June 18 and died June 21, at her residence. She had underlying medical conditions.

At 10 a.m. Central European Summer Time the World Health Organization reported 10,357,662 cases worldwide with 508,055 deaths. In the United States there were 2,573,393 cases with 126,573 deaths.
